

Budget Overview for the 2024-25 School Year




This chart shows the total general purpose revenue Little Shasta Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Little Shasta Elementary School District is \$376,552, of which \$266039 is Local Control Funding Formula (LCFF), \$71728 is other state funds, \$8000 is local funds, and \$30785 is federal funds. Of the \$266039 in LCFF Funds, \$20441 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).


General fund expenditures not included in the LCAP are used for general operating costs including salaries and benefits, cafeteria, utilities, maintenance, and supplies.



Actions 1.2, 1.3, and 1.5 were all eliminated due to a change in funding. There were no other substantive differences in planned actions and actual implementation of these actions for this goal.

Successes: There was significant progress made in providing students with a well-rounded education. Also, over 70% of students are currently working at grade level, a notable improvement from previous years.

Challenges: Actions 1.2, 1.3, and 1.5 were eliminated due to funding changes, which may have impacted certain aspects of the goal implementation and required mid-year adjustments to the original LCAP.



Plan Summary [2024-25]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Little Shasta Elementary School District is a small, one-school district in Siskiyou County, California. The area served is composed of the residences in and around the small community of Little Shasta. There are approximately 20 students in grades TK-8. The student population is limited in racial diversity. Currently, 0% are English Language Learner students. Approximately 10% of the student population participates in the resource Special Education Program. The Special education programs meet the needs of students from various categories of disability through a collaborative model between our school and SCOE.

The school offers a well rounded education for all students. The school is staffed by a teacher/principal/superintendent, and 2 classroom teachers who are 100% appropriately assigned and fully credentialed. In addition we staff a part time instructional aide and lunch coordinator. After School staff includes only one site coordinator. The administrative personnel work cooperatively with each other, the school board, the staff, and parents to ensure a positive environment.

All teacher in the LEA are appropriately assigned and fully credentialed. Every student has sufficient access to the necessary standardsaligned instructional materials. The school facilities are in good condition as evidenced by our passing of the FIT report. Each year repairs and maintenance are performed as needed. We strive to provide a safe, clean environment for all students.

The LCAP will serve in lieu of the School Plan for Student Achievement (SPSA). Additionally, the LCAP educational partners group will serve in lieu of the School Site Council.

The Siskiyou County Office of Education coordinates services for Foster Youth through the positions of Foster Youth Education Director and Foster Youth Services Case Manager. They provide support to our Foster Youth, placed both in and out of Siskiyou County, by helping with transfers, making sure records are moved quickly, and tracking attendance, suspension, expulsion rates and graduation rates to be sure they are equivalent to those of their non-foster peers. They also intervene to refer or provide direct services, including transportation as needed. Because we are a TK-8 school the following state priorities and metrics do not apply to us: Priority 4B, 4C, 4D, 4G, 4H, 5C, and 5E. Acronyms:

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Math: 2022/23 CAASPP Math scores reflect 43% of students met or exceeded standards. This is a 28% decrease in students that are meeting or exceeding the standards on the 2020/21 CAASPP Math assessments. Based on this data there is a significant need to address challenges associated with increasing math performance. These challenges include but are not limited to, needing more one-on-one instruction time to better address and identify academic needs, and increased practice with online testing formatting.

ELA: 2022/23 CAASPP ELA scores reflect 57% of students met or exceeded standards. This is a 14% increase in students that are meeting or exceeding the standards on the 2020/21 CAASPP ELA assessments. Although significant improvements and successes can be identified, there continues to be a need for increased ELA performance and addressing the identified needs of students.

Chronic Absenteeism Rates: The Chronic Absenteeism rate for LSE in 2022/23 was 7.7%. This is a 36% decrease in Chronic Absenteeism from the year prior. Although this significant improvement is encouraging, there continues to be a need for decreased Chronic Absenteeism. There is a direct correlation between LSE's attendance rates and student academic performance. For this reason the LEA should continue practices that encourage student attendance. These practices include increased school/parent communications, attendance incentives for student, and access to our After School Program and Summer Program.

Suspension Rates: LSE maintained a 0% suspension rate for the 2022/23 school year.
