## Plan Summary 2024-25

### General Information

Bellevue-Santa Fe Charter School (BSFCS) is a small, neighborhood conversion K-6 charter school on the Central Coast of California, serving 161 students. We are set amongst farmland in Avila Valley and are surrounded by coastal rolling hills. At the core of BSFCS is the simple yet compelling idea that the education of a student is a shared responsibility and cooperative endeavor between family, school and community. In 1996 when Bellevue was at risk for closing, our school community diligently worked together to convert the school to a charter school and in doing so, became the 93rd charter school in state of California. Today, the students, teachers, administrator, parents, and the community at-large continue to work together to create a unique, compassionate, and inspiring environment where learning is optimized for our students. The BSFCS approach to education challenges students to reach their full potential, nurtures human relationships, and inspires a lifelong passion for learning. At BSFCS, we encourage our students to strive for academic and personal excellence under the guiding principle of Alfred Mercier, “What we learn with pleasure, we never forget.” At the daily school assemblies, our school community may experience the kindergarteners’ dramatic interpretation of a book by Eric Carle or listen intently as a multi-grade class shares original poetry about family memories. With the adopted state standards as a guide, we balance fundamental skill acquisition and application of the main content areas with integrated, project-based design. The curriculum also includes physical fitness and wellness, visual and performing arts, hands-on science labs and garden-based activities, and applied



technologies as integral parts of a well-rounded educational experience for our students implemented with community support. By actively engaging students, bringing joy to the learning process, and making it relatable, children become intrinsically motivated to learn and more fully engaged in life and their relationships. The foundation of our approach at BSFCS has evolved into one of the highest performing schools in our area. The school community continues to demonstrate dedication, passion and support of student learning in multi-grade classrooms. We believe that the development of healthy relationships is a precursor to building strong, resilient minds.

## **Reflections: Annual Performance**

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Our school continues to rank highest in the County on the California Assessment of Student Progress and Performance. Our scores declined in both mathematics (33.7 points) and ELA (10.7 points) but remain above standard by 65.9 points and 33.8 points respectively. All students who participated in the interventions provided for in the LCAP showed significant growth. Parents are actively involved in school volunteerism and parent education. The one area where we show a need is in chronic absenteeism. We ranked as high on the 2023 dashboard at 18.8% this was an increase of 3.4% from the previous year. Normally chronic absenteeism is related to lack of student engagement. In our case, however, our socio-economically advantaged group of families are able to travel, and often choose family vacation dates that coincide with our school calendar. We quarterly remind families of the importance of student attendance, and often publish the calendar with a request for scheduling during non-school days.
