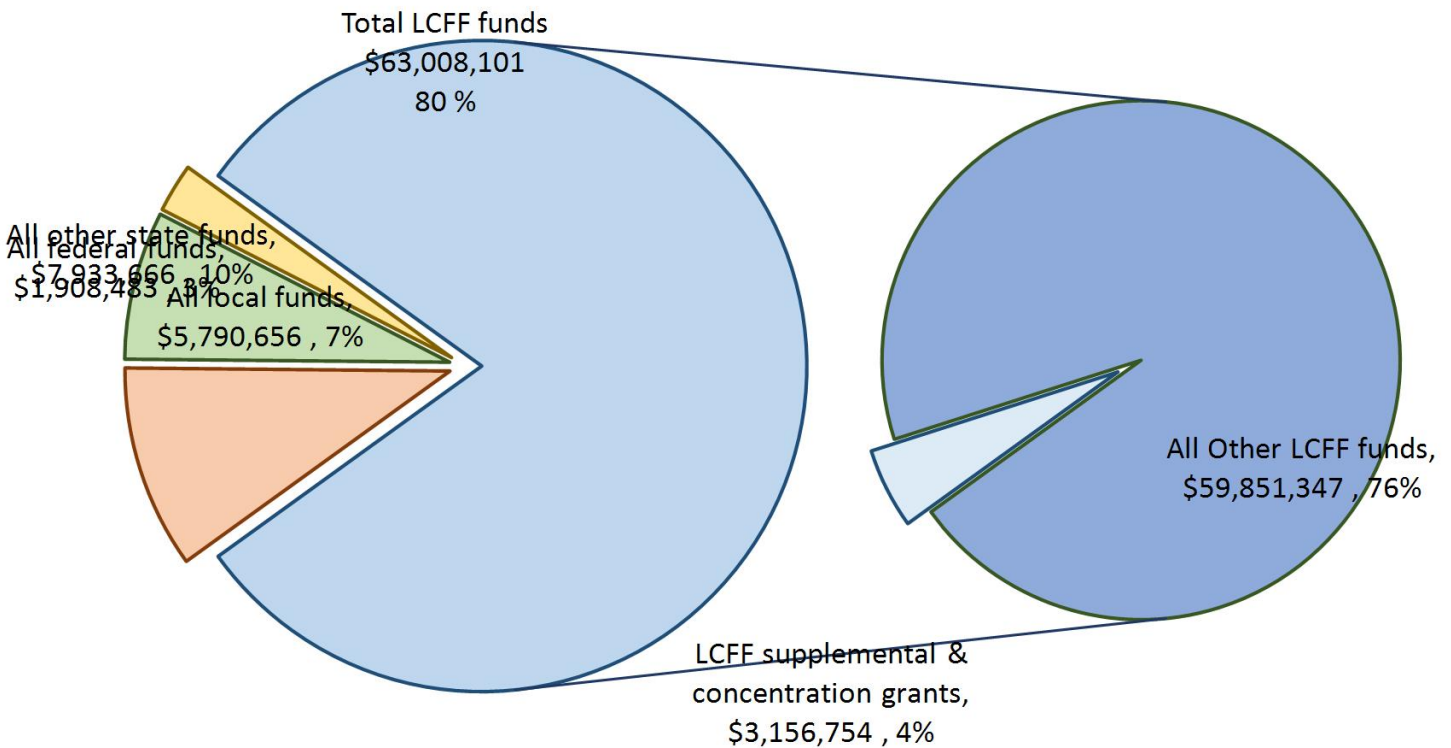

### Projected Revenue by Fund Source

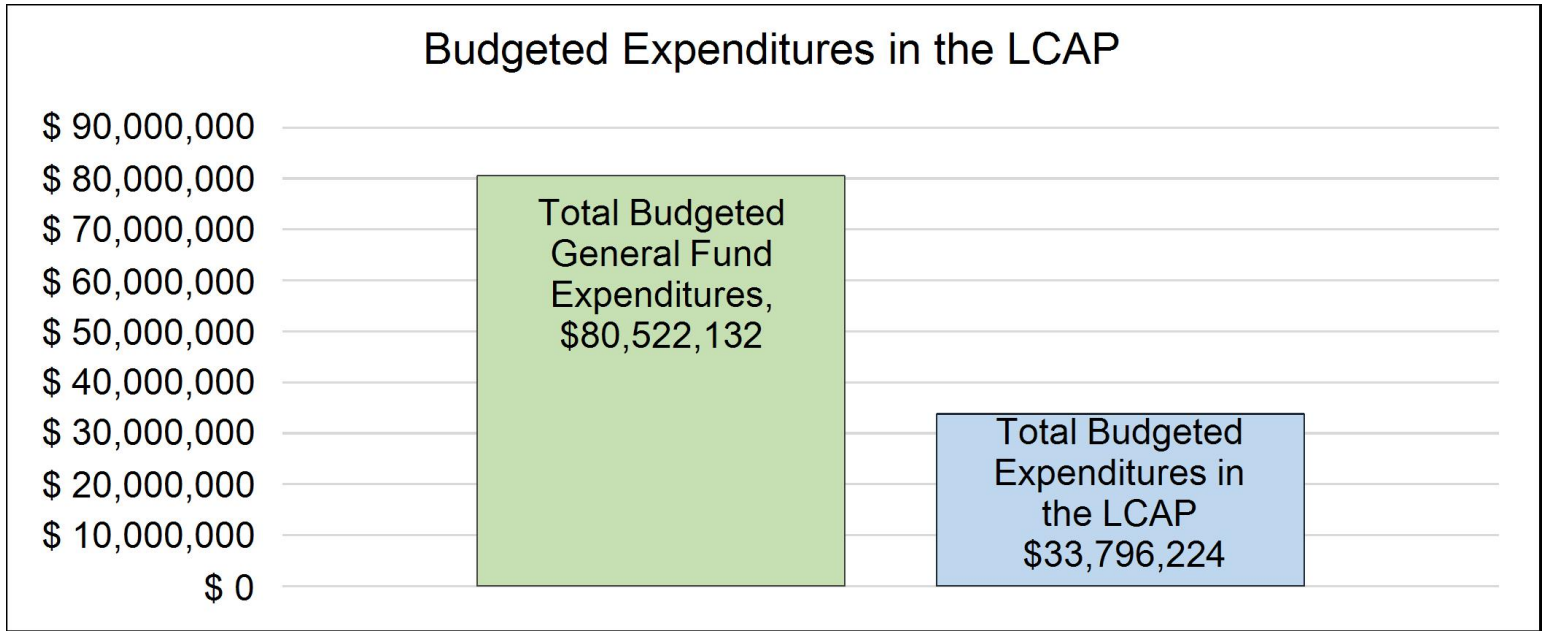


This chart shows the total general purpose revenue Huntington Beach City School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Huntington Beach City School District is \$78,640,906, of which \$63,008,101 is Local Control Funding Formula (LCFF), \$7,933,666 is other state funds, \$5,790,656 is local funds, and \$1,908,483 is federal funds. Of the \$63,008,101 in LCFF Funds, \$3,156,754 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

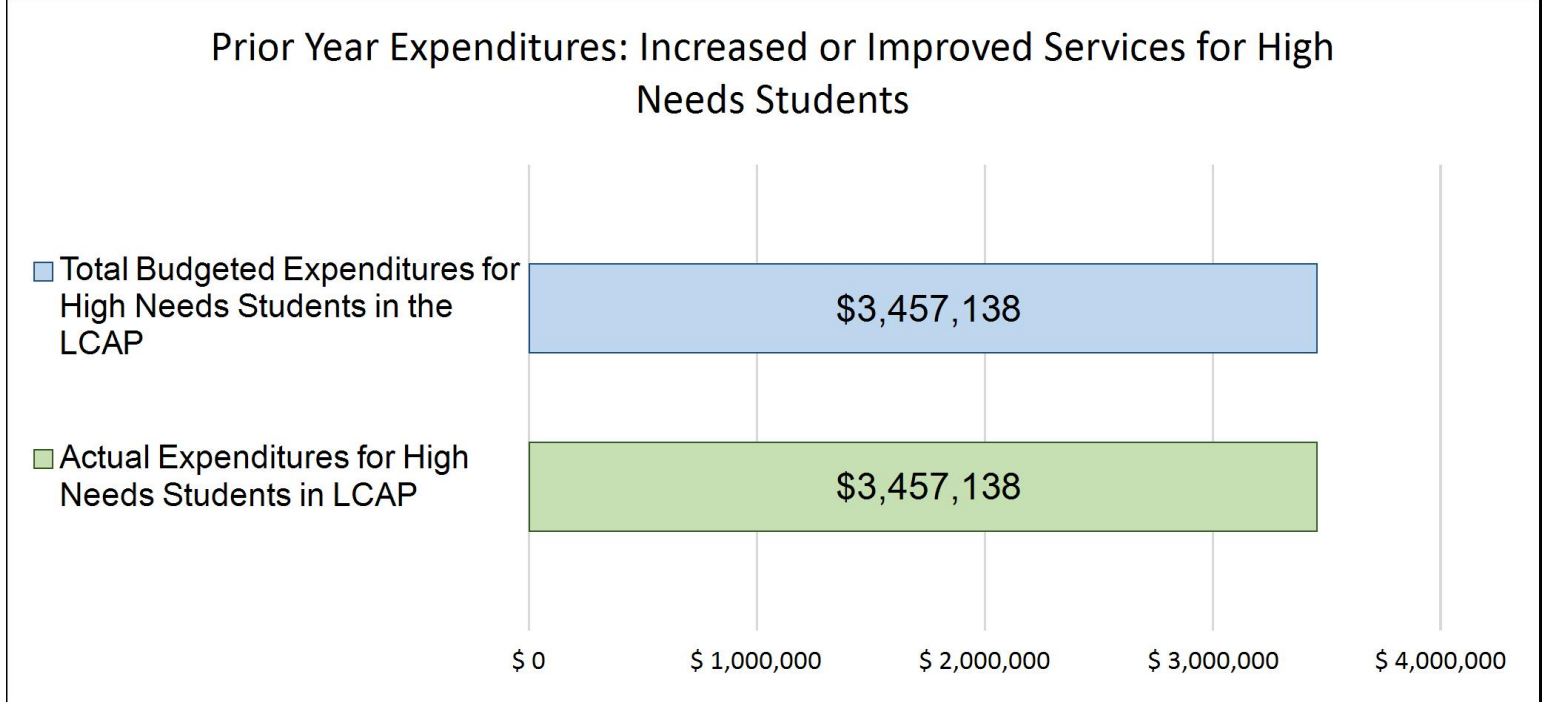
The General Fund (both restricted and unrestricted) expenditures of \$46,725,908 not included in the LCAP are associated with the core activities of the school district. Most of these expenditures are related to educational and related services to students, school administration, library and media services, psychological, speech, transportation, and health services. Additionally, overhead costs associated with operating a school district have not been included, such as maintenance, operations, custodial services, utilities, information technology, general administration services, and debt service payments.

## Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year

In 2025-26, Huntington Beach City School District is projecting it will receive \$3,156,754 based on the enrollment of foster youth, English learner, and low-income students. ## Plan Summary [2025-26]

### General Information

Huntington Beach City School District is located in the city of Huntington Beach in Orange County, approximately 35 miles south of Los Angeles. The coastal city has approximately 194,310 residents and a median household income of \$117,747 with a poverty rate of 7.3% (census.gov, 2023). The district encompasses eight schools and a preschool program. From our six elementary schools (TK-5) to our two middle schools (6-8) and our Preschool Academy, we provide students with a rich and rigorous learning experience. Huntington Beach City School District is one of four elementary school districts that matriculate to the Huntington Beach Union High School District.

The 2024-2025 demographics of our student enrollment in the district are as follows: English learners: 5.08%, Foster Youth 0.24%, Homeless 1.73%, Socioeconomically Disadvantaged 31.3%, Students with Disabilities 13.85%, African American 0.47%, Asian 11.22%, Filipino 0.75%, Hispanic 22.24%, Two or more Races 12.35%, Pacific Islander 0.11%, White 49.50%.

Our current enrollment district is 4,681 with each of our school sites showing the following numbers of students:

Ethel R. Dwyer Middle School: 871 students enrolled

Isaac L. Sowers Middle School: 765 students enrolled

John H. Eader Elementary: 460 students enrolled

Dr. Ralph E. Hawes Elementary: 522 students enrolled

Huntington Seacliff Elementary: 505 students enrolled

SA Moffett Elementary: 406 students enrolled

John R. Peterson Elementary: 527 students enrolled

Agnes L. Smith Elementary: 587 students enrolled

Since 2019/20 school year the district has experienced a 24.05% declining enrollment due to the closure of interdistrict transfer policy, the closure of an elementary school, and rising cost of living along the coast. As a result, our socioeconomically disadvantaged student group has increased by 2-3x the rate at some of our school sites and has increased by more than 11% from Fall 2022 to Fall 2025. 2024-2025 school year marks the transition of the District to community funded. Community funded districts rely primarily on local property taxes for funding. HBCSD continues to allocate funding for LCFF Supplemental to support students identified as foster youth, low income, and English learners.

HBCSD was identified as a Differentiated Assistance district for the following indicators and student groups: LTELS- English Language Arts, Math, Suspension Rate; and Foster Youth of Chronic Absenteeism and Suspension Rate. Staff from HBCSD has participated in data analysis and planning sessions to address the identified needs, including articulation and systems analysis with the surrounding feeder districts and high school districts. Additionally, HBCSD staff met with a northern California district with similar demographics, but have positive outcomes for their LTEL students. They discussed best practices and approaches to supporting students, families, and staff.

Actions 4.2 and 4.4 specifically address Long Term English Learners and foster youth by providing targeted interventions and professional development in the area of language arts and math. Action 3.2 Tiered behavior supports target suspension rates for LTELs. Action 3.3- Interventions for chronic absenteeism addresses foster youth.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

The LCAP was influenced by the feedback provided by educational partners in the following manner:

All educational partners prioritized class size reduction, additional staffing supports (i.e. additional hours for office staff, library media technicians, health clerks, and noon supervisors), and literacy coaches (i.e. TOSAs) to continue to provide academic and social-emotional supports for students, particularly for English learners, low income students, foster youth and students with disabilities. Additional metrics were added to measure parent involvement in middle school and data related specifically to bullying (school climate).

Principals, site administrators, association partners, and teachers focused on ongoing behavior supports with PBIS which include additional support with data system, data analysis and materials to implement PBIS and continued focus on professional development and professional learning communities.

Parents of English learners, Long Term English Learners, foster youth, students with disabilities, homeless, Hispanic, and White students indicated the need for additional interventions and support for academics as well as the need for additional parent resources in the form of parent education.

Student data influenced the continued focus of goal 3 (positive school climate) and its actions.

SELPA provided input on a focus on distance from standard (DFS) as a metric to measure progress of students with disabilities as well as English learners.

An explanation of why the LEA has developed this goal.

Analysis of student performance using SBAC assessments shows evidence of lower student achievement when compared to pre-pandemic levels. Significant gains have been made in providing and taking advantage of professional development opportunities. Input received from educational partners through the LCAP development process indicates a desire to student achievement in English Language Arts and Mathematics for all students. Analysis and input from county office of education indicate that addressing and accelerating learning for student groups continues to remain a priority. The actions listed in goal 1 will contribute to supporting and addressing learning gaps by providing extra time to learn both in school and afterschool as well as focused job embedded professional development on effective instructional strategies and data analysis to improve learning for all students, but specifically for at-risk students, homeless, foster youth and students with disabilities.

## Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

There were no substantive differences in the planned actions and actual implementation. In 2024-2025, several initiatives were executed, including reducing class size, utilizing a combination of Educator Effectiveness, Arts Music Instructional Materials Block grant, and LCFF Supplemental to fund Literacy Coaches, providing 526 substitutes or 129 days of professional development. HBCSD successfully reduced class sizes and utilized the two Literacy Coaches to ensure that every teacher from transitional kindergarten (TK) to 8th grade was trained in Writing from the Beginning and Beyond (WFBB) - Expository/Information writing genre- totaling 32 sessions for 96 hours. The Literacy Coaches also continued training in STAR data analysis, presentations on the HBCSD Literacy Framework, model lessons in classrooms, co-designing and co-teaching lessons, and providing support and feedback during PLCs and in one on one settings.

Professional development included partnering with CA Association for Bilingual Education (CABE) to focus on integrated and designated ELD. The data on English Learner progress (ELPI) does not take into account the increased number of English learners who were reclassified and are no longer part of the student group of English learners making progress toward English proficiency. Additional professional development was provided with Orange County Department of Education in the area of Mathematics and History/Social Science.

Furthermore, professional learning with Marzano Resources consultant assisted HBCSD site administrators and teachers in identifying best practices using High Reliability Schools indicators and curriculum coherence by identifying critical concepts and learning targets.

Supplemental technology, such as Renaissance Suite, ST Math, Nearpod, and Mystery Science continues to support all learners, including English learners, foster youth, and socio-economically disadvantaged students.

There were no material differences between budgeted and estimated actual expenditures for actions under Goal 1.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

As a result of the class size reductions and the emphasis on literacy and reading instruction using the New Art and Science of Teaching and Literacy Coachess to ensure that every teacher from transitional kindergarten (TK) to 8th grade was trained in Writing from the Beginning and Beyond (WFBB) - Expository/Information writing genre- totaling 32 sessions for 96 hours. The Literacy Coaches also continued training in STAR data analysis, presentations on the HBCSD Literacy Framework, model lessons in classrooms, co-designing and co-teaching lessons, and providing support and feedback during PLCs and in one on one settings. The additional professional development and use of professional learning communities enhanced instructional practices by creating a horizontal and vertical coherence. As this is the first year of development, there is slight growth in CAASPP ELA (0.5%) and more noticeable growth in CAASPP Math with 3.48% growth. Students with disabilities at Dwyer demonstrated a 7.02% growth from the baseline year.

The data on English Learner progress (ELPI) does not take into account the increased number of English learners who were reclassified and are no longer part of the student group of English learners making progress toward English proficiency. Additionally, Long Term English Learners are now a student group and an area of focus in 2025-2026.

There are no additional metrics or action added to goal 1. Instead, additional metrics and actions related to Long Term English Learners (LTELs) have been added to goal 4 (academic achievement of student groups), specifically Long Term English Learners (LTEL)s for ELA and Math and to implement newcomer program. HBCSD has experienced an increase in newcomers enrolling in our schools this year.

An explanation of why the LEA has developed this goal.

HBCSD's strategic plan has a focused goal on creating safe and supportive environments. When surveyed on the LCAP survey, 64% of parents strongly agree and agree that they are involved in their child's education and decision making. However, when compared to the CA Healthy Kids Survey - Parent module, data further revealed that 62% of elementary parents feel the district and school promotes parental involvement and decision making, whereas only 25% of middle school parents feel the district and school promotes parental involvement and decision making. Open ended responses further reveal that students and parents indicate a desire for more opportunities to be included in decision-making processes and desire for more activities that are engaging or enjoyable that cater to the interests of all students. Parents reported inconsistent application of school policies, particularly related to discipline and classroom management which left some participants mentioned feeling uncomfortable or unwelcome at school.

## Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

All actions outlined in the 2024-2025 LCAP Goal 2 were successfully executed. Communication tools such as Zoom, SeeSaw, Canvas, and ParentSquare were fully integrated. According to a recent parent survey, 81% of respondents stated that their level of trust in HBCSD is either the same or better than the previous year. Furthermore, 81% of participants favored ParentSquare as their communication method, with 86% expressing satisfaction with district communications, an increase of 13% when compared to the previous year. Community liaisons not only conducted parent education series but also expanded outreach and services to families by participating in school events such as festivals, performances, and monthly PTA meetings. Additionally, webinars were recorded to provide parent education resources accessible at any time, ensuring convenience for parents. One challenge encountered in implementing actions during 2024-2025 was increasing parent participation in parent education sessions. Although parents continued to volunteer at high rates at the school/classroom level, attendance for in-person parent education sessions remained low. However, recorded parent education sessions on the district's YouTube channel continue to be accessed by parents, especially for topics that have been available longer.

There was a slight decrease in perceptions of parental involvement, particularly in the elementary school. However, there was an increase of 8% of middle school parents' perception of parental involvement. Suspension rates have had a slight decrease with Sowers exceeding the goal of reducing suspension rate for students with disabilities by 9.8%. Dwyer Middle School suspension rate for students with disabilities was Very Low (Red) on the 2024 CA Dashboard. With the addition of Long Term English Learners as a student group, LTELs will be added to monitoring.

There were no substantive differences in planned actions and implementation. All actions were fully implemented.

There were no material differences between budgeted and estimated actual expenditures for actions under Goal 2.

As a result of intentional use of communication tools, which includes ParentSquare and the ability to send out communication in the parents' language of preference, there was an increase of 8% of middle school parents' perception of parental involvement. However, there was a slight decrease in perceptions of parental involvement, particularly in the elementary school. As a result of direct phone calls made by community liaisons to middle school families regarding parent education nights and community meetings, suspension rates have had a slight decrease with Sowers exceeding the goal of reducing suspension rate for students with disabilities by 9.8%. Dwyer Middle School suspension rate for students with disabilities was Very Low (Red) on the 2024 CA Dashboard. With the addition of Long Term English Learners as a student group, LTELs will be added to monitoring.

Action 2.4 (Parent Education- MS, EL, preschool) and 2.5 (Literacy Resources for Home) will be discontinued. Dwyer Middle School suspension rate for students with disabilities was Very Low (Red) on the 2024 CA Dashboard. With the addition of Long Term English Learners as a student group, LTELs will be added to monitoring. Additionally, the LCAP Advisory Committee had requested adding the metric of Canvas Parent Observer rates to monitor parent involvement.

There were no substantive differences in the planned actions and actual implementation. Each school site attended PBIS trainings with their leadership teams and monitored student behavior utilizing PBIS Rewards data system and developing site based tiered behavior supports. Sites identified as ATSI in 2023-2024 were provided additional supports to address chronic absenteeism, which has resulted in their removal from ATSI status. Allocations were provided to library services to purchase collections that demonstrate representation of our students in novels, books, and literature. Collections were also purchased to promote connections beyond Huntington Beach and to promote collaboration.

There were no material differences between budgeted and estimated actual expenditures for actions under Goal 3.

Focused behavior and chronic absenteeism supports have demonstrated effective with schools and district demonstrating significant decreases in chronic absenteeism and suspension rates. Particular area of significant decrease is that of Homeless students' chronic absenteeism rate, a decrease of 28.1% and meeting Year 3 goals. There was an increase in chronic absenteeism for foster youth and Dwyer Middle School's SWD were now Very Low (Red) on the 2024 CA Dashboard. With the focus on middle school in 2024-2025, we noticed a slight decrease in parent perceptions at the elementary.

Analysis of student achievement data of student groups identified that a gap exists in the performance of students meeting/exceeding grade level standards when compared to their peers as evidenced by distance from standard on CAASPP assessments in ELA and Math. Distance from Standard measures how far, on average, students are from the lowest possible score for Standard Met. On average student groups performing below standard range from 16.7 to 40.9 points for English learners, Students with Disabilities, and homeless in ELA. In Math, English learners and homeless are performing 33.6 and 72.5 points below standard, respectively.

Most actions outlined in LCAP Goal 4 for the 2024-2025 academic year were successfully implemented. This included initiatives such as targeted interventions, afterschool enrichment as well as ELD (English Language Development) Designated and Integrated training. Middle School SEL curriculum was not purchased. Instead, school counselors created lessons based on challenging behaviors reported to counselors and in student referrals. For example, if there were increases in student teasing or conflicts between students, counselors implemented schoolwide lessons addressing the topic and followed up with small group instruction.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between budgeted and estimated actual expenditures for actions under Goal 4.

Focus on targeted academic interventions and ongoing support and training for students with disabilities marked growth, particularly at Smith Elementary School which closed the gap by 46.1 point growth. However, growth for English learner progress and LTELs are stagnant. Reclassification rates for English learners declined while we experienced increases in the number of newcomer English learners. Action 4.1 (middle school SEL) is discontinued.

Action 4.1 (middle school SEL) is discontinued. LTEL Distance from Standard will be a metric that will be added to the 2025-2026 LCAP. An increase expenditures in supports for targeted academic interventions will be added.

## Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning, particularly to address and reduce disparities in opportunities and outcomes between student groups indicated by the California School Dashboard (California Education Code [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. LEAs should continually evaluate the hard choices they make about the use of limited resources to meet student and community needs to ensure opportunities and outcomes are improved for all students.
- **Meaningful Engagement of Educational Partners:** The LCAP development process should result in an LCAP that reflects decisions made through meaningful engagement (EC Section 52064[e][1]). Local educational partners possess valuable perspectives and insights about an LEA's programs and services. Effective strategic planning will incorporate these perspectives and insights in order to identify potential goals and actions to be included in the LCAP.

- Annually reviewing and updating the LCAP to reflect progress toward the goals (EC Section 52064[b][7]).
- Ensuring that all increases attributable to supplemental and concentration grant calculations, including concentration grant add-on funding and/or LCFF carryover, are reflected in the LCAP (EC sections 52064[b][6], [8], and [11]).

The LCAP template, like each LEA's final adopted LCAP, is a document, not a process. LEAs must use the template to memorialize the outcome of their LCAP development process, which must: (a) reflect comprehensive strategic planning, particularly to address and reduce disparities in opportunities and outcomes between student groups indicated by the California School Dashboard (Dashboard), (b) through meaningful engagement with educational partners that (c) meets legal requirements, as reflected in the final adopted LCAP. The sections included within the LCAP template do not and cannot reflect the full development process, just as the LCAP template itself is not intended as a tool for engaging educational partners.

- **Total Funds:** This amount is automatically calculated based on amounts entered in the previous four columns.
- **Planned Percentage of Improved Services:** For any action identified as contributing, being provided on a Limited basis to unduplicated students, and that does not have funding associated with the action, enter the planned quality improvement anticipated for the action as a percentage rounded to the nearest hundredth (0.00%). A limited action is an action that only serves foster youth, English learners, and/or low-income students.
  - As noted in the instructions for the Increased or Improved Services section, when identifying a Planned Percentage of Improved Services, the LEA must describe the methodology that it used to determine the contribution of the action towards the proportional percentage. The percentage of improved services for an action corresponds to the amount of LCFF funding that the LEA estimates it would expend to implement the action if it were funded.

As part of the annual update process, the LEA reviews implementation and student outcome data and determines that the action was implemented with fidelity and that outcomes for foster youth students improved. The LEA reviews the original estimated cost for the action and determines that had it hired additional staff to collect and analyze data and to coordinate supports for students that estimated actual cost would have been \$169,500 due to a cost of living adjustment. - **4. Total Planned Contributing Expenditures (LCFF Funds)**
  - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
  - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
  - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

### **Contributing Actions Annual Update Table**

Pursuant to EC Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7).   - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

## **LCFF Carryover Table**

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
