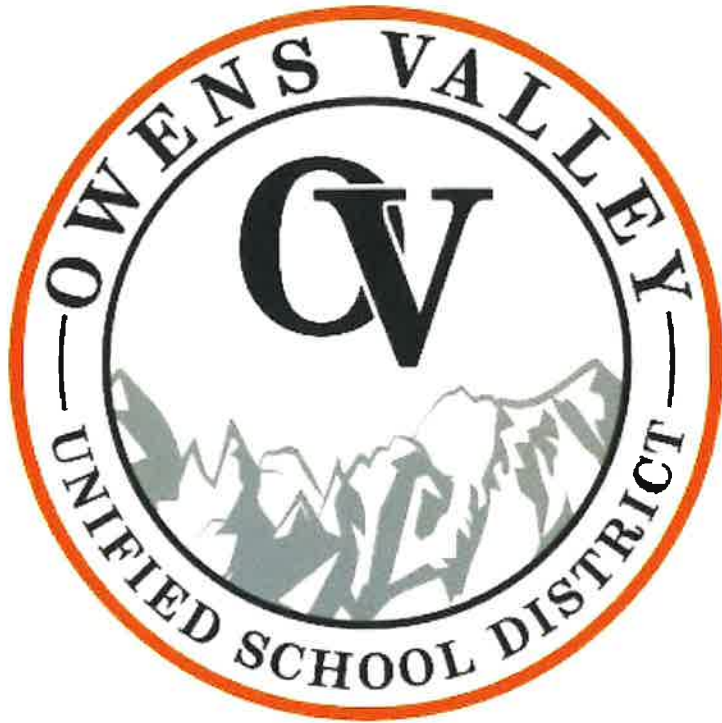

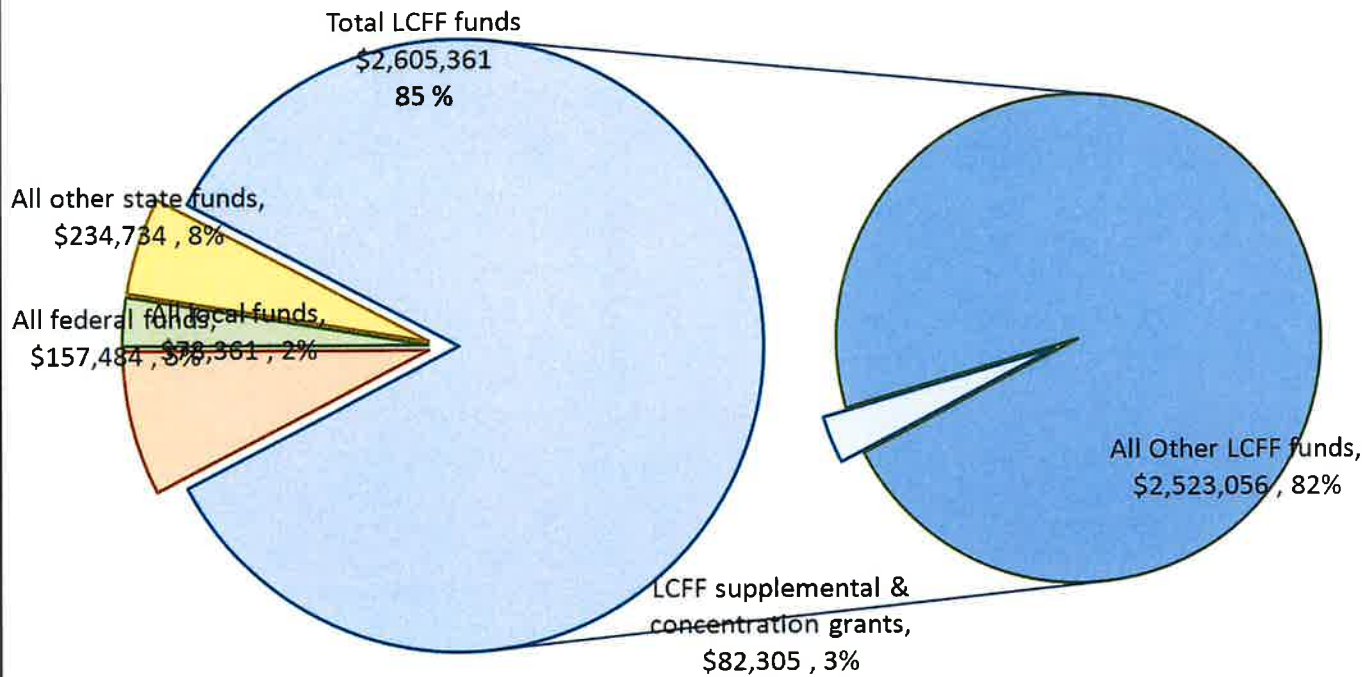

Projected Revenue by Fund Source

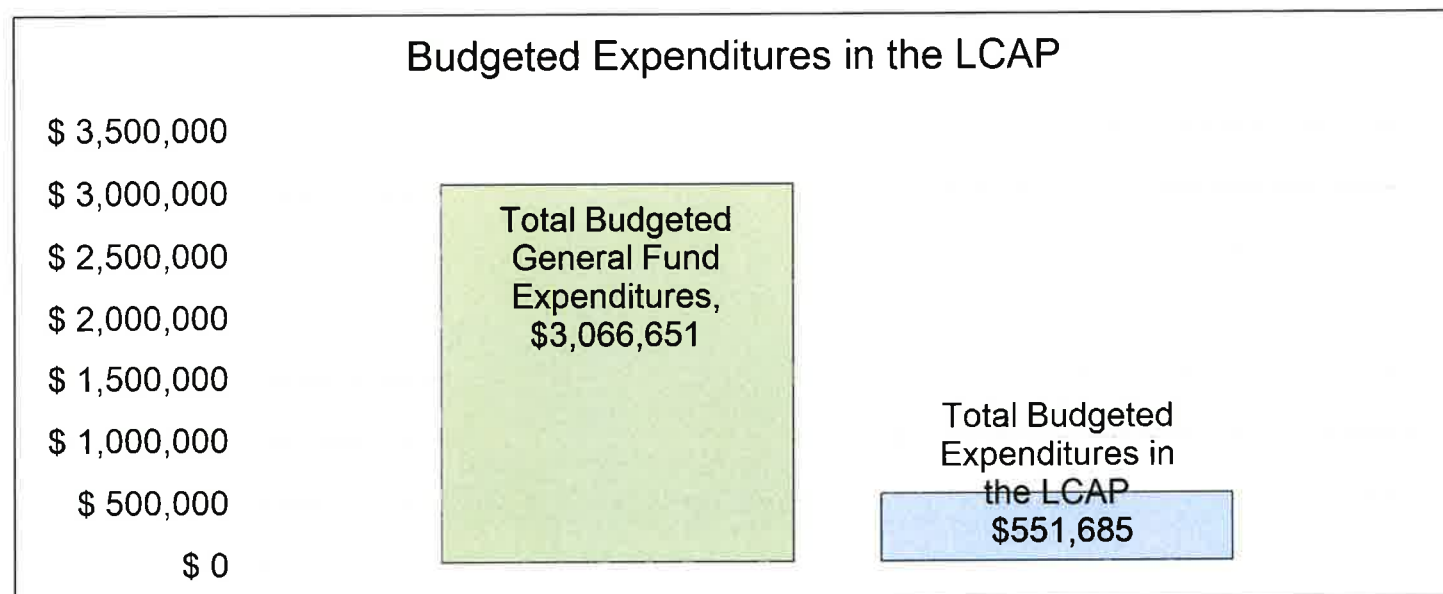


This chart shows the total general purpose revenue Owens Valley Unified School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Owens Valley Unified School District is \$3,075,940, of which \$2,605,361 is Local Control Funding Formula (LCFF), \$234,734 is other state funds, \$78,361 is local funds, and \$157,484 is federal funds. Of the \$2,605,361 in LCFF Funds, \$82,305 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

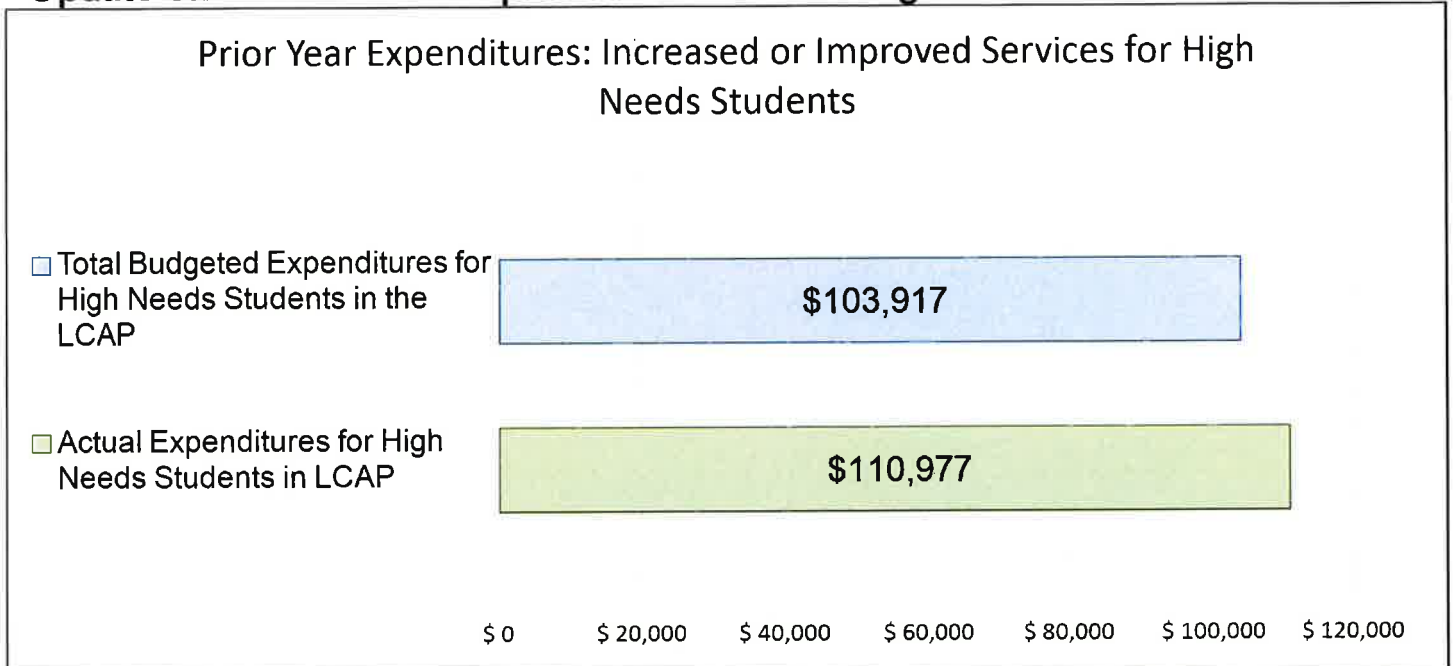

Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, Owens Valley Unified School District is projecting it will receive \$82,305 based on the enrollment of foster youth, English learner, and low-income students. Plan Summary [2024-25]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Owens Valley Unified is a very small TK-12 district located in Independence, CA. The district currently has 112 students enrolled. Owens Valley Elementary consists of students in the elementary and middle grades, TK-8. Students in grades 9-12 are enrolled at Owens Valley High School. Both schools share one campus and school facilities. Our student body is ethnically diverse, comprised of approximately 43%

Hispanic students, 28% White students, 10% American Indian students, and 10% Multi-Ethnic/Other students. There are fewer than 11 students that are classified as English Learners for 2024-25. Approximately 58% of the students are socio-economically disadvantaged.

OVUSD prides itself on our small class sizes and the personalized education that we offer to each student.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

We have put substantial effort into alternatives to suspension and the promotion of school attendance, offering independent study to parents when they need to be out of town for medical appointments. The teaching and paraprofessional staff have been engaged in Multi-Tiered Systems of Support professional development and our TK-8 teachers have implemented a Tier I daily intervention program to help address students' areas of academic need.

Rationale:

Currently, Owens Valley has fewer than 11 EL students. Progress will be monitored on an individual basis. Due to the small size of the high school, CTE course offerings vary each year and this is not a reliable measure. No CTE pathways are established as of 2023-24. As with CTE pathway completion, A-G completion, high school dropout rate and graduation rates also cannot be reported publicly to protect student privacy. These rates are monitored by the LAE on a student by student basis. The district operates it's two schools as one entity on a single campus and all students matriculate from 8th grade to high school.

At OVUSD there are no schools nor student groups that received the lowest performance level on one or more state indicators on the California School Dashboard.

Through the WASC process, college and career readiness emerged as an area of focus. The district must provide a welcoming environment so that students feel safe and connected to the school. A welcoming environment for families will allow the school to solicit input for future improvement. Establishing strong relationships between students and staff members will allow students to get the needed support to achieve at the highest level. Promoting PBIS structures will help improve classroom and school culture.

- This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

- This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
