




This chart shows the total general purpose revenue Bogus Elementary School District expects to receive in the coming year from all sources.



All actions were fully implemented, except for action 1.1 curriculum review, due to no curriculum being available to view at the county office since they have done a remodel of the resources room. Therefore the school decided to try a few samples and trials of curriculum to be sent to the school. This resulted in no subs being needs, therefore no costs. There were no particular challenges in implementing these actions except for finding professional development that was available during times that was accessible for the teacher to attend.

There were no major material differences between Budgeted expenditures and Estimated Actual expenditures aside from purchasing of a curriculum.

- 1.1- The LEA decided to try a few samples and trials of curriculum to be sent to the school. This resulted in no subs being needs, therefore no costs.
- 1.3- The LEA researched several and did a trial of one but it did not fit well with teachers and classroom. Therefore we are rolling over that expense for the coming year to continue research and trails and saving up enough to purchase a complete set of social studies curriculum (grades K-8).
- 1.4- Similar to 1.1, due the the single teacher being on site, professional develop workshops scheduled during school hours are difficult to attended.

Student scores almost doubled in all areas for CAASPP scores. There was growth in STAR reading and slight decrease in STAR math. Therefore planned actions were effective in achieving the goal.

We removed action item 1.1 since curriculum reviews are no longer needed. All other action items remained the same.

# **Plan Summary [2024-25]**

## **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Bogus Elementary School was established in 1872 and, except for a brief time, has been open since. We are located in the far northern part of the state near Copco Lake in a remote rural farm area in Siskiyou County--one of the largest counties in California, with one of the smallest populations.

The county is described as frontier, with less than 11 persons per square mile, and has no census defined place within the area with a population exceeding 50,000.

The county's 25 school districts are small and serve approximately 5,871 students. With over 6,000 square miles in the county many districts, such as ours, are remotely located in very small communities with very limited resources.

There are currently 17 students at Bogus Elementary, with 0 English Language Learner student.

Foster subgroups vary in number are rarely over 2 families.

Special education subgroups vary in number and have ranged from 1 to 4.

Approximately 85% of our students are low-income.

Bogus Elementary has 1 teacher/principal and 1 aide to serve our students. In addition to our regular core program, we offer an amazing music program which includes Native American flute, guitar, and piano. A special education teacher and speech therapist services are provided weekly through the County Office of Education. Science has become a big focus for our school in recent years. We purchased a new curriculum and partner with the Outdoor Science Program offered through the County Schools office. We offer the Siskiyou After school For Everyone (S.A.F.E.) program which is tied into our regular curriculum to extend and enrich learning. We focus on hands-on experiences in the after school program. We also offer our facilities to older students, that have already graduated from Bogus Elementary and have chosen to home-school for their high school years, so they can continue their studies online within an educational environment.

## **Reflections: Annual Performance**

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

After reviewing the CA Dashboard data and local data, we have maintained our progress in ELA and Mathematics. Students have improved every year in both subjects. This year, all but two students where on grade level in the star test, both of which have IEP's. We will concentrate efforts in best first instruction and supplementation instruction through targeted interventions. We will identify and target students using data from local measures to drive instruction and believe this will result in growth for our students.

Chronic Absenteeism continues to be a byproduct of the pandemic. We will be making concerted efforts to target students and families to identify areas of support to ensure students are coming to school. Our chronic absenteeism rate was 44.4% in 2022 according to the Dashboard. Our goal is to do reduce that to 20% in the next few years. Educating families and students on the importance of attending school will be focused on. Providing exciting opportunities at the school that make students excited to attend will be a goal in our LCAP for the next three years.

#### An explanation of why the LEA has developed this goal.

In the 2022/2023 CAASPP ELA test, only 28.57% of students 3-8th grade scored 'exceed or met standard'. In math, the same group of students scored 21.43% 'exceed or met' standards. In science, 0% of students scored 'exceed or met'. After reviewing the results, our LEA decided that purchasing curriculums that aligned with CA state standards was a top priority. When the LEA completed Priority 2 self-assessment tool on Dashboard, we did not meet the standards for 'fully implemented' in Science and Social Studies. These two factors combined guided the LEA's decision to make sure students had access to quality curriculum that aligns with state standards.

This goal was developed based on analyzed data and stakeholder input to ensure that Bogus School District students are supported in having up to date curriculum and well training and assigned teachers. Implementing the actions below and measuring progress using the identified metrics will support Bogus Elementary School District in achieving the goal.
