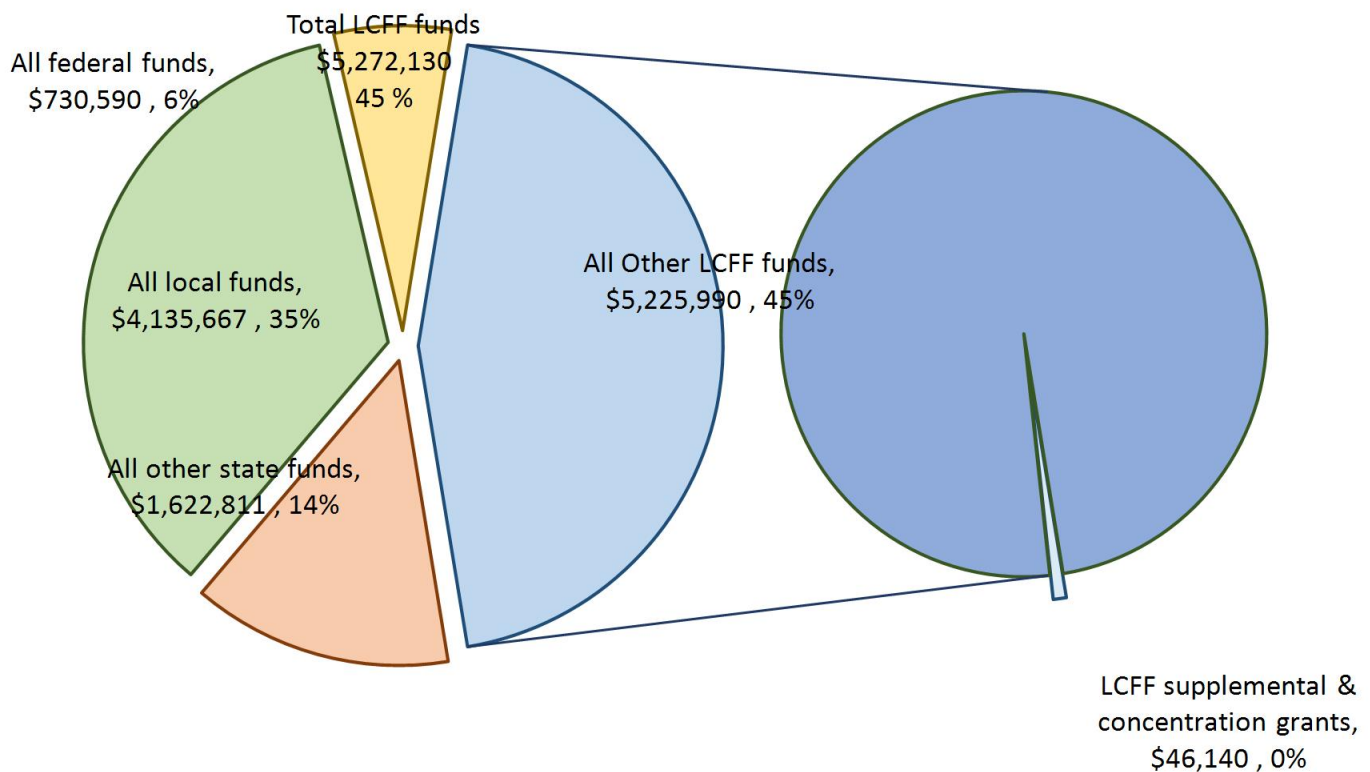

Projected Revenue by Fund Source

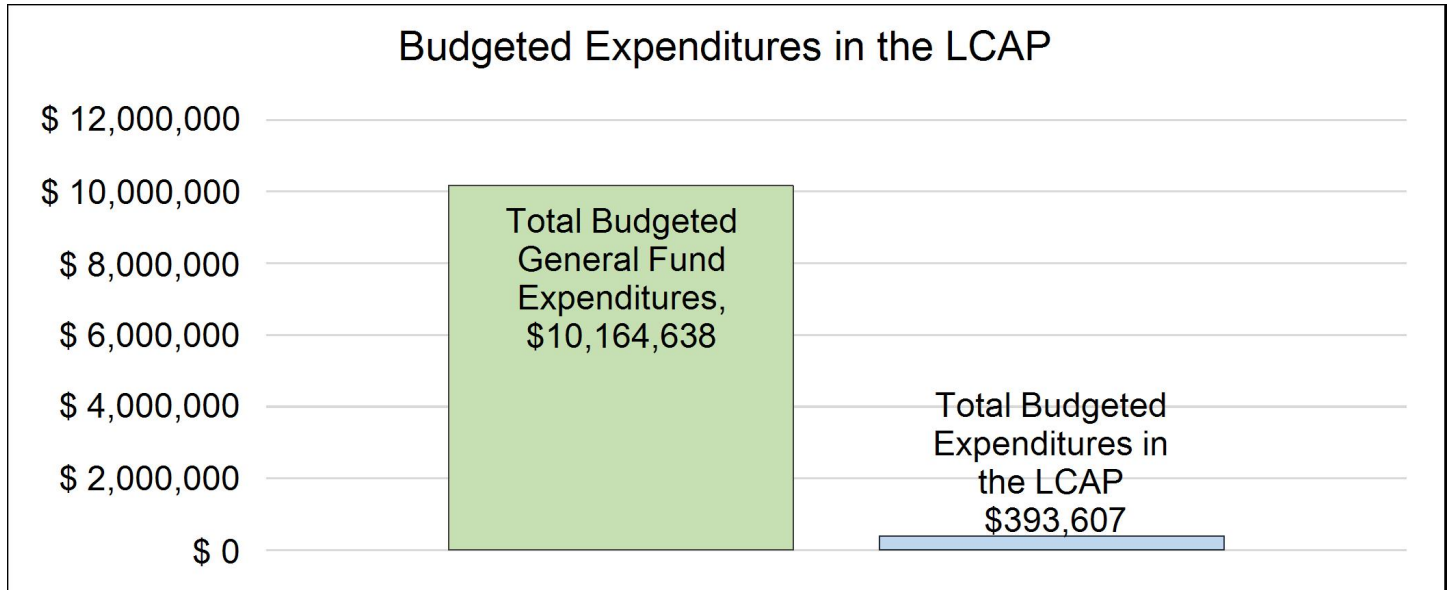


This chart shows the total general purpose revenue Nevada County Superintendent of Schools expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Nevada County Superintendent of Schools is \$11,761,198, of which \$5272130 is Local Control Funding Formula (LCFF), \$1622811 is other state funds, \$4135667 is local funds, and \$730590 is federal funds. Of the \$5272130 in LCFF Funds, \$46140 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

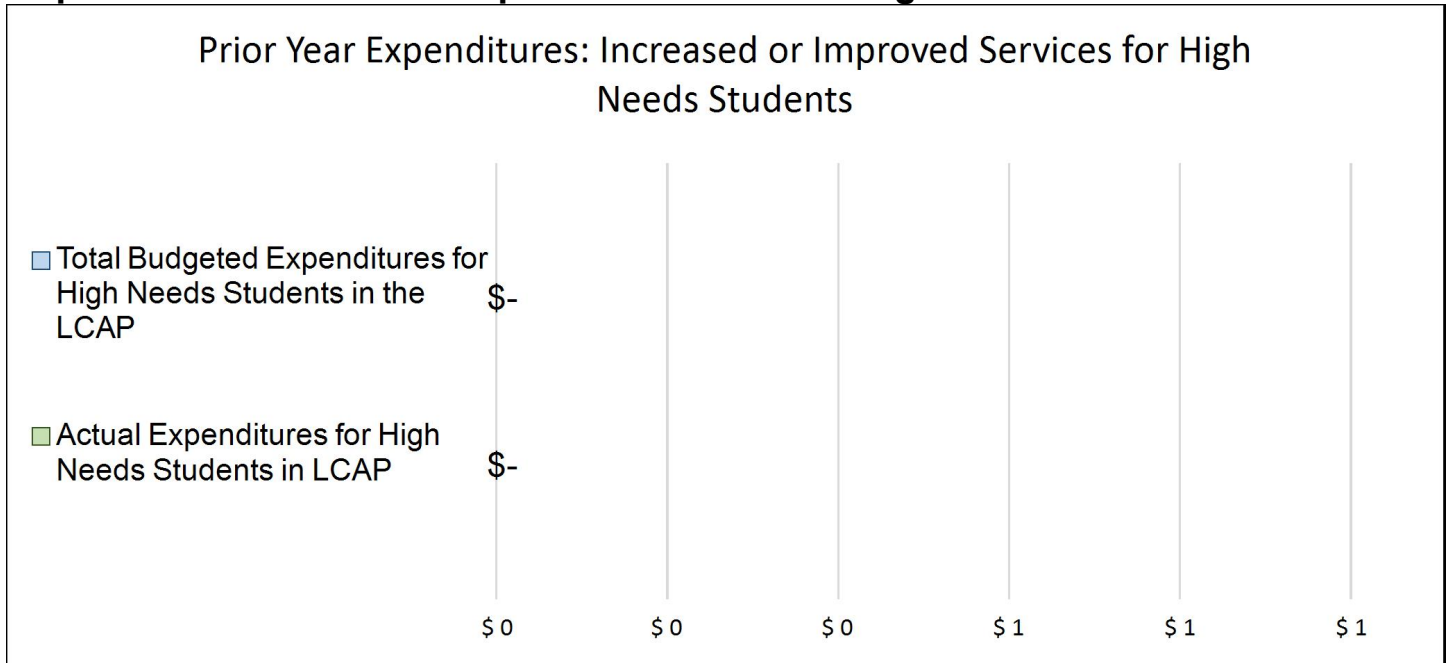
General Fund expenditures include costs to provide services for oversight and support to county Local Educational Agencies, expenditures associated with grant funded special programs and operational costs for the County Office.

Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, Nevada County Superintendent of Schools is projecting it will receive \$46,140 based on the enrollment of foster youth, English learner, and low-income students. We are pleased with the continued positive outcomes of the planned actions and the aligned metrics showing implementation. There were no notable substantive differences in planned actions and actual implementation of the planned actions. Graduate rates for Foster Youth were not as we expected however, all three foster youth seniors will be returning to a fifth year.

Material differences noted for actions 3.1 and 3.2 were due to a salary increase for all NSCOS employees. The funds expended in both of those actions are personnel related and the salary increase was not agreed upon until after the adoption of the 23-24 LCAP.

Each of the specific actions in goal three 3.1, 3.2 and 3.3 were deemed effective based on their assigned metrics over the three year LCAP cycle. Plan Summary [2024-25]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

The Nevada County Superintendent of Schools (NCSoS) Office serves a predominantly rural population. The most recent data from the 2022 census indicated, from a population of approximately 102,293 citizens, Caucasians make up 93 percent of the county population. The remainder of the population includes Hispanic (10%), Asian (2%), African American (1%), and Native American (1%).

NCSoS office provides supports and services to the nine comprehensive school districts and 13 charter schools in Nevada County. NCSoS also authorizes seven charter schools, two of which are statewide. The total LEA population served is 10,930 countywide. NCSoS does not operate any educational programs. The County Community School, Earle Jamieson Educational Options, has an existing CDS code but NCSoS has signed an MOU that transfers the day to day operations and the academic program to John Muir Charter School. NCSoS will maintain attendance and assessment data for those students enrolled in Earle Jamieson based on the enrollment guidelines that our outlined in the NCSoS Plan for Expelled Youth. John Muir Charter school will address academic outcomes for all students they serve, including those at Earle Jamieson, in their Local Control Accountability Plan. Earle Jamieson Educational Options has been identified as an Equity Multiplier school. NCSoS will work with John Muir Charter School to provide the necessary support to reduce suspensions. In partnership with John Muir, it was determined that the equity multiplier funds that we received on behalf of the students at EJ would be best utilized to support intervention, behavior, and mental health supports.

NCSoS facilitates the Foster Youth Services Coordinating Programs (FYSCP) that are captured in CALPADS (any youth who meets the Local Control Funding Formula definition of foster that is school aged K-12) which includes those in placement, family reunification, and family maintenance. We also serve foster transition age youth, voluntary cases, and non-dependent legal guardianships. Our team regularly attends community meetings where the focus is on prevention and early intervention to work collaboratively at increasing school stability, coordination of services and strengthening relationships between foster program participants and local service agencies. Our program supports services to close foster youth achievement gaps so that students in foster care can reach their full potential, and reach college and career goals while becoming independent, productive members of society. NCSoS will continue to provide exemplary service and countywide educational support to our Foster Youth students as well as providing transitional support and Independent Living Skills training to youth who are aging out of the foster youth system.

NCSoS serves as a liaison between the California Department of Education and the schools and districts within Nevada County. We serve as a continuous improvement regional service and support provider for the districts and charter schools within the county and serve as the administrative unit for the county Special Education Local Area Plan (SELPA) providing regional support. The LCAPs for school districts and charter schools within the jurisdiction of the Superintendent of Nevada County contain specific goals, actions and services to support students with exceptional needs and are available on the NCSoS website (www.nevco.org).

- **Contributing to Increased or Improved Services?:** Type "Yes" if the action **is** included as contributing to meeting the increased or improved services requirement; OR, type "No" if the action is **not** included as contributing to meeting the increased or improved services requirement.
- If "Yes" is entered into the Contributing column, then complete the following columns:
 - **Scope:** The scope of an action may be LEA-wide (i.e., districtwide, countywide, or charterwide), schoolwide, or limited. An action that is LEA-wide in scope upgrades the entire educational program of the LEA. An action that is schoolwide in scope upgrades the entire educational program of a single school. An action that is limited in its scope is an action that serves only one or more unduplicated student groups.

- **Unduplicated Student Group(s):** Regardless of scope, contributing actions serve one or more unduplicated student groups. Indicate one or more unduplicated student groups for whom services are being increased or improved as compared to what all students receive.

The LEA reviews the original estimated cost for the action and determines that had it hired additional staff to collect and analyze data and to coordinate supports for students that estimated actual cost would have been \$169,500 due to a cost of living adjustment. The LEA would divide the estimated actual cost of \$169,500 by the amount of LCFF Funding identified in the Data Entry Table and then convert the quotient to a percentage. Contributing Actions Table

- **4. Total Planned Contributing Expenditures (LCFF Funds)**
 - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
 - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**

- This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

Pursuant to *EC* Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - This amount is the Total Estimated Actual Expenditures for Contributing Actions (7) subtracted from the Total Planned Contributing Expenditures (4).

- **5. Total Planned Percentage of Improved Services (%)**

- This amount is the total of the Planned Percentage of Improved Services column.

- **8. Total Estimated Actual Percentage of Improved Services (%)**

- This amount is the total of the Estimated Actual Percentage of Improved Services column.

- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**

- This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**

- This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
 - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
- **13. LCFF Carryover — Percentage (12 divided by 9)**
 - This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
