




This chart shows the total general purpose revenue Cuddeback Union School District expects to receive in the coming year from all sources.

Of the \$1,936,099 in LCFF Funds, \$265,316 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



In 2024-25, Cuddeback Union School District is projecting it will receive \$265,316 based on the enrollment of foster youth, English learner, and low-income students. Action 1.1 was not implemented for the majority of the year. The Moby Max contract expired and district is in process of re-evaluating criteria for a benchmarking program for ELA and Math.

All other actions associated with this goal were implemented.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

- Action 1.1: district spent \$6,200 less due to not renewing benchmarking program.
- Action 1.10: district spent \$8,000 less due to slight reduction in employee FTE at employee request.
- Action 1.11: district reduced unrestricted contribution to transportation due to increased transportation funding from the state.
- Action 1.12: district reduced unrestricted contribution to cafeteria due to increased universal meals funding from the state.
- Action 1.13: district increased spending \$14,000 due to increased building costs associated with this program.

Contributing Actions 1.11 & 1.12 continue to be an effective tool for the district in transporting students to school and ensuring good nutrition at no cost.

Contributing Actions 1.3 & 1.9 are deemed effective in contrast to Dashboard data showing a slight decrease in ELA & Math scores in 2 of 3 years. We believe that the impact of COVID had a more significant role in the stagnation of those scores. Also, primary reading results and middle/upper grade GPA improved over those years.

Goals 1 & 2 of this LCAP have been restructured into a single academic achievement based goal. We found that there was much duplication in actions and intent of these 2 goals, and for efficiency and clarity have streamlined them into a single encompassing goal moving forward.

Action 2.11: district did not expend the \$10,590 planned for IT services.

Actions 2.4, 2.8, 2.9 were effective based on the CA Dashboard data that shows the students maintained achievement levels coming out of COVID. Actions 2.5 & 2.6 related to technology were effective as demonstrated by maintaining achievement levels on CA Dashboard data.

Goals 1 & 2 of this LCAP have been restructured into a single academic achievement based goal. District intends to be more intentional to increase effectiveness of professional development and training opportunities for teachers, staff and admin in the next LCAP years.

- Action 3.10: district increased expenditures by \$2,200 mostly due to adding a cheerleading team this year.
- Action 3.12: district spent \$5,000 less due to not finding a certificated music teacher, utilized a classified music instructor instead.
- Action 3.13: district increased expenditures by \$13,000 in providing increased services related to social/emotional support for students.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

Contributing actions 3.13 & 3.14 have been very effective for our students. Actions 3.4 - 3.12 have also been effective and are the identity of our school. The high district student attendance rates, below state average chronic absentee rate, low suspension/expulsion rates, and student's high level of connectedness to school all support this claim.

Action 3.15 related to facilities is also effective as reflected in the overwhelming positive feedback provided regarding facilities and maintenance of the school.

The next LCAP has been restructured to include just 2 goals. This required moving some actions from the current Goal 3 into the new Goals 1 & 2. Those actions and associated metrics remain substantially the same as before.

Actions 3.7,8,9 were eliminated from the next LCAP since they were not associated with required metrics and those actions were linked to very little or no funding.

Plan Summary [2024-25]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Cuddeback Union School District is a small, single-site elementary school district located in Carlotta serving approximately 160 students in grades TK through 8th. Nestled in the rural Van Duzen River Valley, the district boundaries run the 12 miles along Highway 36 from Yager Creek to Grizzly Creek. Most of the students living within the boundaries live within one mile of the highway.

The district is known for maintaining a family--like culture where teachers, staff, and administration know virtually every child by name. Many current parents at our school were once students in the same classrooms that their children now attend. Parents are welcomed and have many opportunities to interact and be involved on campus. Parents often mention the positive school climate and well-rounded approach to education at Cuddeback School as highly valued pieces they appreciate in their child's experience.

Attributed mainly to school size and culture, the district has roughly a 50% interdistrict population of students. Interdistrict student demographics are very representative of the in--district children and the school population overall. Cuddeback's student body identifies as approximately 69% white, 15% Hispanic, 4% American Indian or Alaskan Native, and 11% as 2 or more races. The district unduplicated rate for the 2023-24 school year is 62% according to the CALPADS data. Students with disabilities represent roughly16% of school enrollment; with 0 EL students, and 0 Foster youths currently enrolled.

The decline of the timber industry has significantly impacted the town of Carlotta over many years. Once, multiple employment opportunities were present as lumber mills, country stores, and restaurants supported the town. Today there are no markets or restaurants operating in the town of Carlotta. The long term impact of the recent focus of farm-related agriculture and legal cannabis cultivation is undetermined at this point, but so far has negatively affected the local economy. Many families are struggling to find new means of economic support.

The district believes that the efforts expended on social/emotional learning and support outlined in the LCAP are responsible for maintaining a 0% (blue) on suspensions and expulsions for our students.

Contributing actions - such as classroom instructional aides, counseling services, intervention services, nutrition and transportation - directed primarily at our largest student group (socioeconomically disadvantaged) seem to be effective as that group increased scores in both ELA and math, 11.5 points and 15.6 points respectively.

Programs and actions to support SWD also showed positive growth in chronic absenteeism, as well as ELA and math scores.

With a school district of our small size, there is opportunity to interact with virtually all educational partners numerous times throughout the year. CUSD is able to carry on its daily operations without any collective bargaining units, therefore no input was gathered from such.

Opportunities to communicate, share ideas, and engage with our educational partners are typically plentiful in our small Cuddeback community. Our informal and family-like climate allows for a great deal of conversational and 1:1 input settings, as well as the formalized structured settings for educational partner input. The Superintendent, teachers, and staff had daily opportunities to communicate and gather input from parents. Many parent questions and concerns were heard and addressed during the student morning and afternoon drop-off and pickup sessions.

The District offers opportunity for public educational partners input specifically related to the LCAP via a standing agenda item at each monthly School Board meeting. The District has provided additional engagement opportunities for expenditure plans requiring a Public Hearing or separate meetings for input and Board approval meetings as required.

Credentialed and classified staff provided input and discussion at regular staff meetings.

Consultation with students took place all throughout the year in 1:1 conversations, small group discussions, class meetings, and our student climate survey.

Student observations, conversations, class meetings, and program participation all were very insightful means to review, analyze, and plan our LCAP. Regular interaction ensures that all students, including our unduplicated and students with disabilities populations, had opportunities for their input to be considered.

Parent and student surveys are utilized to gather engagement and safety data each school year. That input is considered appropriately as expenditure plans are developed in an effort to support students in academic and social/emotional learning and progress.

Parent and community partners, including parents of unduplicated and SWD, had opportunities to participate in the process through monthly Board meetings, IEP meetings, PTO, Parent Advisory Group meetings, and parent-teacher conferences. Online surveys, written notices, and automated messaging (phone/email/text) with updates and invitations for parent participation also reach our families on a regular basis throughout the year.

The feedback gathered from parents/guardians placed a continuing emphasis on maintaining a positive school climate, as this is a main reason that many of our interdistrict families make the effort to travel to Cuddeback. The district continues to provide extensive social/emotional support actions and resources in the LCAP.

Related to providing a safe and engaging educational setting, the feedback from families and students encourages the district to provide students with increased opportunities for involvement in co-curricular activities during the school day and after school, maintain a before-school care program (ELOP), develop a broader music program, and continue our Restorative Practices based SEL program. Staff feels that efforts are needed to improve and sustain parent/community engagement so there are even more involved people in decision making. The district will expend resources to actively develop such strategies in this LCAP.
