General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Alpine County Schools is a single-single District / County Office of Education. Alpine County is located in Eastern California nestled within the Sierra Nevada Mountains and is 743 square miles in area. According to the 2020 US Census there are 1,204 residents. This is a 2.4% increase from the 2010 census.

Prior to the county's creation in 1864 the Washoe people, a Great Basin tribe, inhabited the area. It is still the home of the Hung-A-Lel-Ti community.

Alpine County Office of Education operates the Alpine County Opportunity School and the Alpine Early Learning Center. The California state preschool program at the Alpine Early Learning Center is funded through the Alpine County Unified School District. Alpine County Unified School District operates two TK-8 schools, Diamond Valley Elementary and Bear Valley Elementary, and the Alpine County Secondary Community Day School. Students in grades 9-12 attend South Tahoe High School in El Dorado County, CA, Douglas High School in Minden, NV, or Bret Harte High School in Calaveras County, CA.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Alpine County Schools is proud of the work we have done to improve educational opportunities for our students of all ages. In 2022 Alpine County Unified School District was identified for Differentiated Assistance due to high rates of chronic absenteeism and high rates of suspension. The 2023 dashboard indicated improvement and the district has been removed from Differentiated Assistance. Despite these improvements, the district continues to refine practices and promote family engagement as a way to further improve campus climate, attendance, and reduce student discipline issues. Diamond Valley Elementary School continues to qualify for Continuous Support for Improvement as they work on further improving student attendance and suspension rate. Local data reveals that students are continuing to make progress in academic subject areas, especially in English Language Arts as the district began a professional development initiative focused on the CA ELA/ELD Framework and instructional practices. The district-wide focus on family engagement led to improved family attendance at campus events, especially student performances.

Alpine County Office of Education programs focused on providing early childhood and alternative placement opportunities for the children of our community. The Alpine Early Learning Center has had to re-evaluate staffing needs at several points throughout the year as the need for quality child care has continued to increase in need. Leadership worked to eliminate financial barriers to care through partner subsidies, changes in fee schedules, and assisting families to every extent possible. Despite moving students of TK age to the school district campuses, wait lists have had to be instituted for enrollment. The Alpine County Opportunity School provided alternative high school placement for students who were not performing successfully in other area high school programs. Despite its small size, the school is celebrating two high school graduates!

Reflections: Technical Assistance

Alpine County Office of Education provides technical assistance to Alpine County Unified School District in several ways and in partnership with our geolead partners at Sacramento County Office of Education and Placer County Office of Education. ACOE, as overseen by PCOE, has provided Differentiated Assistance guidance over the last year. ACOE led staff meetings with ACUSD staff to analyze root causes of chronic absenteeism and disciplinary disturbances, and to create plans to address these issues. ACOE worked with ACUSD to monitor attendance monthly and has reported results of these efforts to staff and community members. ACOE is also guiding ACUSD through the rewriting of the district discipline matrix and has provided professional development training to staff on trauma informed practices. ACOE and PCOE have worked with the California Collaborative for Inclusive Learning to infuse all professional development and school programming with the tenants of the universal design for learning. ACOE, with the support of SCOE, has provided technical assistance in support for expanded learning programs, providing staff training opportunities, program exploration, and providing feedback on site visits.

In partnership with the campus principal and geographic lead support from Placer County Office of Education, Alpine COE and ACUSD will support the Diamond Valley Elementary School campus in reducing rates of chronic absenteeism. Currently, ACOE has engaged with Diamond Valley Elementary School in conversations regarding attendance data, including historical and current trends. Upon presentation of these data, an attendance committee was formed at the campus and regularly updates the COE of ongoing attendance issues as well as successes. The team meets regularly and is in communication with families to find out what supports are needed to improve student attendance. The ACUSD Native Liaison has worked with families to establish a late transportation route for students who miss the school bus in the morning. Students defined as chronically absent or who have borderline attendance have been closely monitored. Future supports will include empathy interviews, root cause analysis, and monthly monitoring of attendance data to celebrate improved rates of attendance. Training in trauma informed practices and culturally appropriate pedagogy were also offered to all staff to improve the culture and climate of the campus and provide staff supports for difficult behaviors that have reduced suspensions and absences. In addition to direct support to students and families for attendance, the district has worked diligently to improve family engagement at the school site, including providing transportation as needed to school events and reaching out to community groups and families to remind them of upcoming events. ACOE monitors monthly attendance reports and assists the school in recognizing students and staff members who have perfect attendance.

ACOE and ACUSD have monitored monthly attendance reports and rewarded students and staff members for exemplary attendance. ACOE has also reported out monthly rates of attendance to the community and has worked with community organizations to determine the causes of fluctuations. ACOE and ACUSD have also created a document with the campus principal to monitor students at risk of becoming chronically absent so that campus staff can intervene before students hit that threshold.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

The 2024 LCAP was developed with feedback from all educational partners as detailed above. ACOE and ACUSD have engaged with staff, parents, students, and the public via one-on-one conversations, newsletter updates requesting feedback and input, surveys, and provided periodic updates to the board and community in public meetings. We are a very small community that asks a lot from our educational partners. Because all members of our community wear many hats, personally and professionally, scheduling meetings remains a challenge. Through one-on-one feedback, emails, and survey results we feel confident in moving forward with this LCAP plan.

Alpine County is very small and creating parent advisory committees can be difficult. After many years of trying to form an LCAP Parent Advisory Committee, Alpine County Schools has created A-PAC, the Alpine Parent Advisory Committee that meets every other month to discuss current school issues, find solutions, provide opportunities for students, and provide the school district and county office of education with guidance on school site matters, continuous improvement, bond funds, and budgeting. A-PAC consists of all interested parents including those who are low-income, Native American, and those who have students with disabilities. Members of both the certificated and classified

unions also collaborate with parents at A-PAC meetings. A-PAC and ACUSD administrators heavily weighed Dashboard data as well as staff and student feedback to create goals focused on improving campus climate, reducing discipline issues, and reducing chronic absenteeism.

School attendance is key to academic success, and yet ACUSD continues to hover near 50% chronic absenteeism rates. Students need to be motivated to attend school through engaging instruction and programming, and encouraged by parents who will feel more connected to their school sites through authentic engagement opportunities. This is also the only area in which we have student groups in the "red" level according to the 2023 California School Dashboard. Special attention will need to be paid to offer opportunities for student and parental engagement that target American Indian and socioeconomically disadvantaged families.

Data and the California Schools Dashboard show that ACUSD students are underperforming in English Language Arts and Mathematics when compared to their peers around the state of California. 29% of ACUSD students met or exceeded the ELA Standard, performing 74.4 points below the standard on ELA while California students averaged 13.6 points below the standard. 23% of ACUSD students met or exceeded the Math Standard, scoring 91 points below the standard, while California students averaged 49.1 points below the standard in Math.

Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning, particularly to address and reduce disparities in opportunities and outcomes between student groups indicated by the California School Dashboard (California *Education Code* [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. LEAs should continually evaluate the hard choices they make about the use of limited resources to meet student and community needs to ensure opportunities and outcomes are improved for all students.
- **Meaningful Engagement of Educational Partners:** The LCAP development process should result in an LCAP that reflects decisions made through meaningful engagement (EC Section 52064[e][1]). Local educational partners possess valuable perspectives and insights about an LEA's programs and services. Effective strategic planning will incorporate these perspectives and insights in order to identify potential goals and actions to be included in the LCAP.
- **Accountability and Compliance:** The LCAP serves an important accountability function because the nature of some LCAP template sections require LEAs to show that they have complied with various requirements specified in the LCFF statutes and regulations, most notably:

Section 52052 identifies long-term English learners as a separate and distinct pupil subgroup with a numerical significance at 15 students.

- Annually reviewing and updating the LCAP to reflect progress toward the goals (*EC* Section 52064[b][7]).
- Ensuring that all increases attributable to supplemental and concentration grant calculations, including concentration grant add-on funding and/or LCFF carryover, are reflected in the LCAP (*EC* sections 52064[b][6], [8], and [11]).

The LCAP template, like each LEA's final adopted LCAP, is a document, not a process. LEAs must use the template to memorialize the outcome of their LCAP development process, which must: (a) reflect comprehensive strategic planning, particularly to address and reduce disparities in opportunities and outcomes between student groups indicated by the California School Dashboard (Dashboard), (b) through meaningful engagement with educational partners that (c) meets legal requirements, as reflected in the final adopted LCAP. The sections included within the LCAP template do not and cannot reflect the full development process, just as the LCAP template itself is not intended as a tool for engaging educational partners.

If a county superintendent of schools has jurisdiction over a single school district, the county board of education and the governing board of the school district may adopt and file for review and approval a single LCAP consistent with the requirements in *EC* sections 52060, 52062, 52066, 52068, and 52070. The revised LCAP template for the 2024–25, 2025–26, and 2026–27 school years reflects statutory changes made through Senate Bill 114 (Committee on Budget and Fiscal Review), Chapter 48, Statutes of 2023.

- This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
